

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL MONTE, CALIFORNIA CONFIRMING THE CONDUCT OF A NOVEMBER 3, 2009 GENERAL MUNICIPAL ELECTION CONSOLIDATED WITH THE UNIFORM DISTRICT ELECTION LAW ELECTION ADMINISTERED BY THE COUNTY OF LOS ANGELES ON THE SAME DAY AND DECLARING THE APPROVAL OF THE RESULTS OF SAID ELECTION AS PROVIDED BY LAW

APPROVAL OF ELECTION RESULTS  
GENERAL MUNICIPAL ELECTION - NOVEMBER 3, 2009

WHEREAS, the City of El Monte ("City") conducted a General Municipal Election on Tuesday November 3, 2009 for the election of one Mayor, two City Council members, one City Treasurer and one City Clerk; and

WHEREAS, the City's November 3, 2009 election also included the submission of two ballot initiatives: Measure P (reorganization of City Council structure; elimination of elected Mayor office) and Measure RR (advisory ballot measure regarding overnight parking); and

WHEREAS, the City's November 3, 2009 General Municipal Election was consolidated with the Uniform District Election Law election of the same day which is administered by the Registrar-Recorder/County Clerk for the County of Los Angeles; and

WHEREAS, notice of the election was given in the time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL MONTE, CALIFORNIA, DOES FIND, DECLARE, ORDER AND RESOLVE AS FOLLOWS:

SECTION 1. That on November 3, 2009 the City of El Monte undertook a consolidated General Municipal Election administered by the Registrar-Recorder/County Clerk for the County of Los Angeles (hereinafter the "Registrar"). For purposes of this resolution the aforementioned November 3, 2009, County-administered consolidated general municipal election shall hereinafter be referred to as the "Election";

SECTION 2. That on November 23, 2009, the Registrar issued a *Certificate of the Canvass of the Election Returns* for the Election. (A true and correct copy of the Registrar's November 23, 2009 Certificate of the Canvass of Election Returns is attached and incorporated hereto as **Exhibit "A"**);

SECTION 3. That the names of persons voted for at the election of Mayor were as follows:

Andre Quintero  
Ernest G. "Ernie" Gutierrez

That the names of persons voted for at the election for member of the City Council were as follows:

Norma Macias  
Juventino "J" Gomez  
Richard Garner  
Art Barrios  
Kien Lam  
Angel Ralph Nunez

That the two ballot initiatives voted upon at the election were as follows:

Measure P – A City Council sponsored ballot initiative to reorganize the structure of the El Monte City Council from a City Council composed of one elected mayor and four elected city council members to a structure composed of five elected city council members each of whom shares the title of mayor on a rotating basis.

Measure RR – A City Council sponsored advisory ballot measure that sought to gauge public support for the establishment of an overnight parking restriction in the City of El Monte.

SECTION 4. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which such persons were candidates is listed in **Exhibit "A"** attached.

SECTION 5. The City Council does hereby declare and determine that:

- Andre Quintero was elected as Mayor for the full term of two years;
- Juventino "J" Gomez was re-elected as a Member of the City Council for a full term of four years;
- Norma Macias was elected as a Member of the City Council for a full term of four years;
- Henry J. Velasco was re-elected as City Treasurer for a full term of four years;
- Lorene Gutierrez was re-elected as City Clerk for a full term of four years;
- Measures P which sought to reorganize the structure of the City Council was disapproved by a majority of the voters; and
- With respect to advisory Measure RR, a majority of voters disapproved of the proposal to establish an overnight parking program for the City of El Monte which would restrict overnight parking on most City streets.


SECTION 6. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (a) The whole number of ballots cast in the City; (b) The names of the persons voted and the measures voted for; (c) for what office each person was voted for; (d) the number of votes given at each precinct to each person and on the measure; and (e) the total number of votes given to each person and the measure.

SECTION 7. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election Return signed by the Registrar-Recorder/County Clerk of the County of Los Angeles and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the


office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 8. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.


